Signatory List Submittal and Maintenance of Lists

Signatory List Submittal and Maintenance of Lists

For Group Programs:

- Submission of the entire signatory list is required at time of new program application.
- Any changes to the list must be submitted as an update to Apprentice Training Representative (ATR) within 90 days of the change in unprotected electronic spreadsheet (e.g. MS Excel).
- Updates must include the signatories' name, address, and FEIN (or ER Number) and indicate whether each signatory is being added or deleted.
- This is required per the Regulations so we know which employers are signatory to which programs so we can verify apprentices.
- Template to use when submitting changes - Group Program Signatory List Template (AT 702):

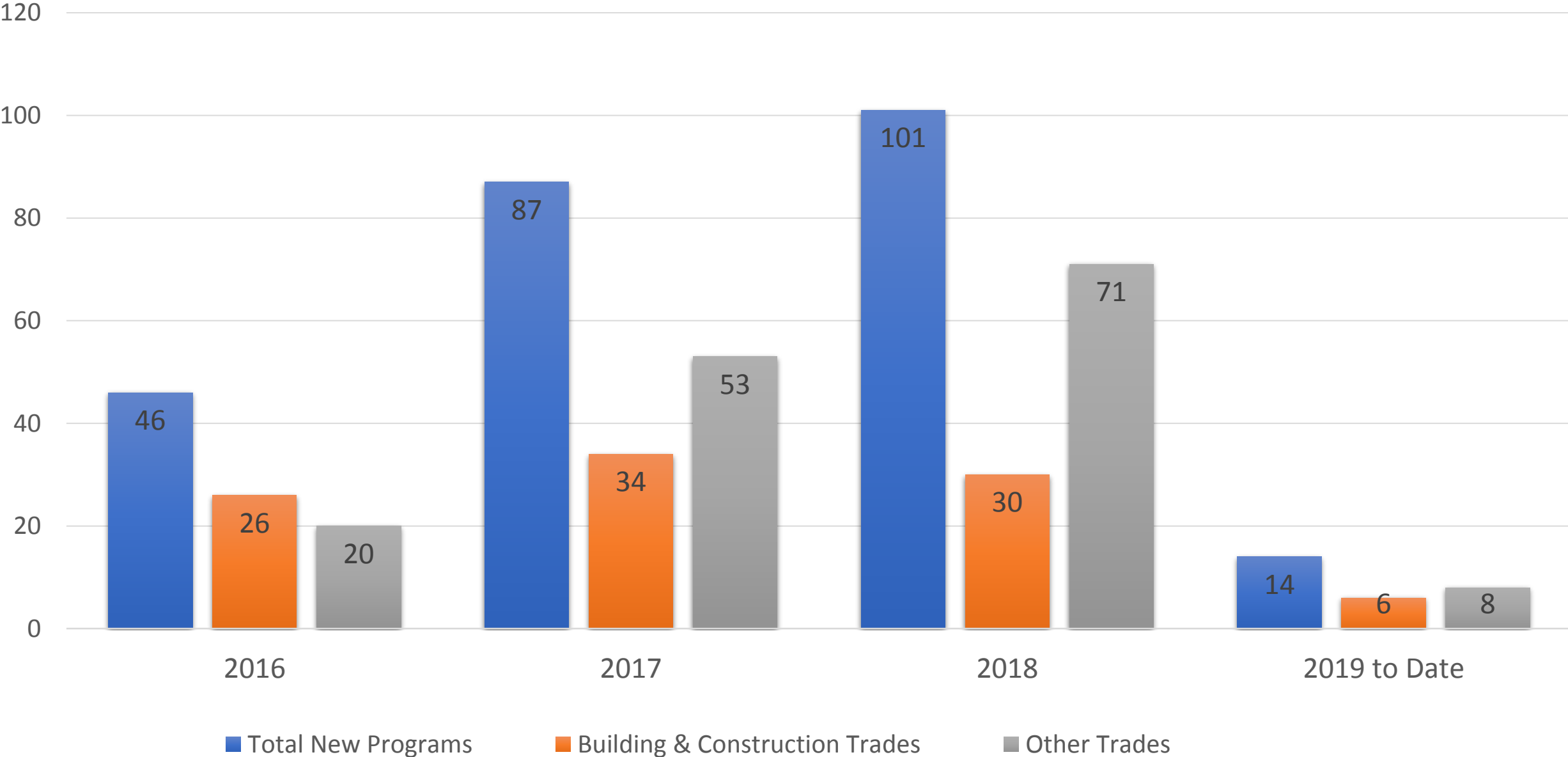

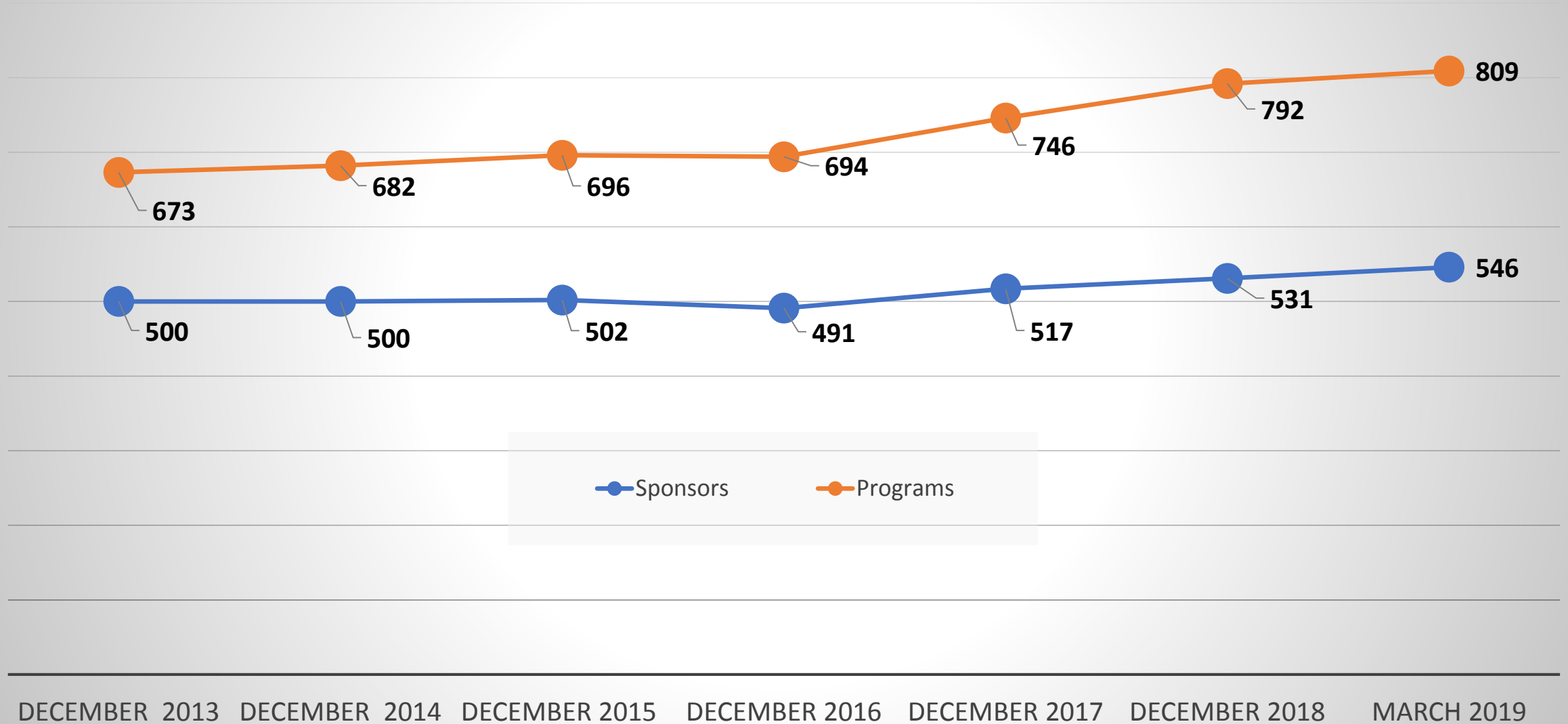

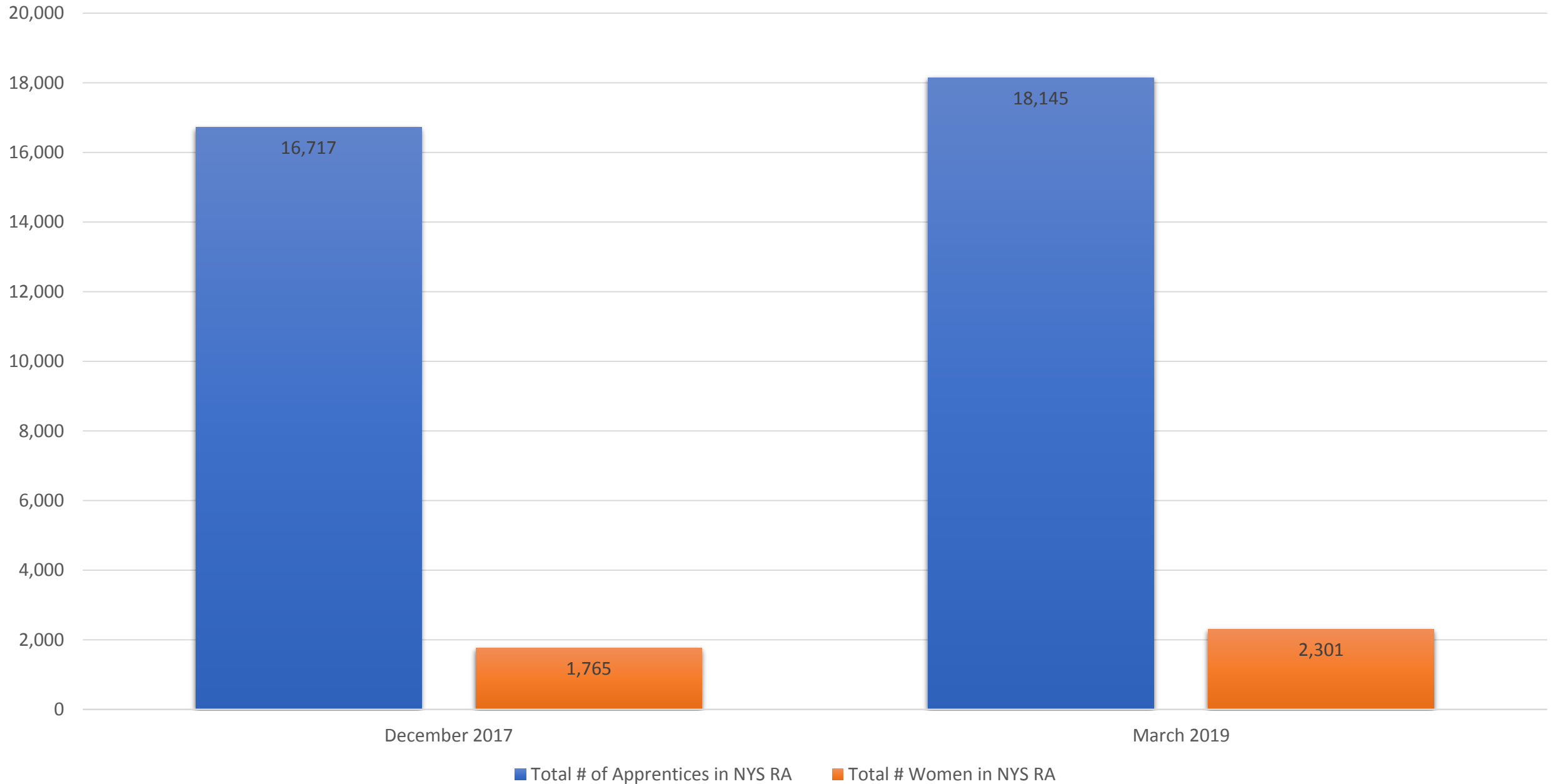

2019 to Date: The Year in Review – Apprenticeship Data

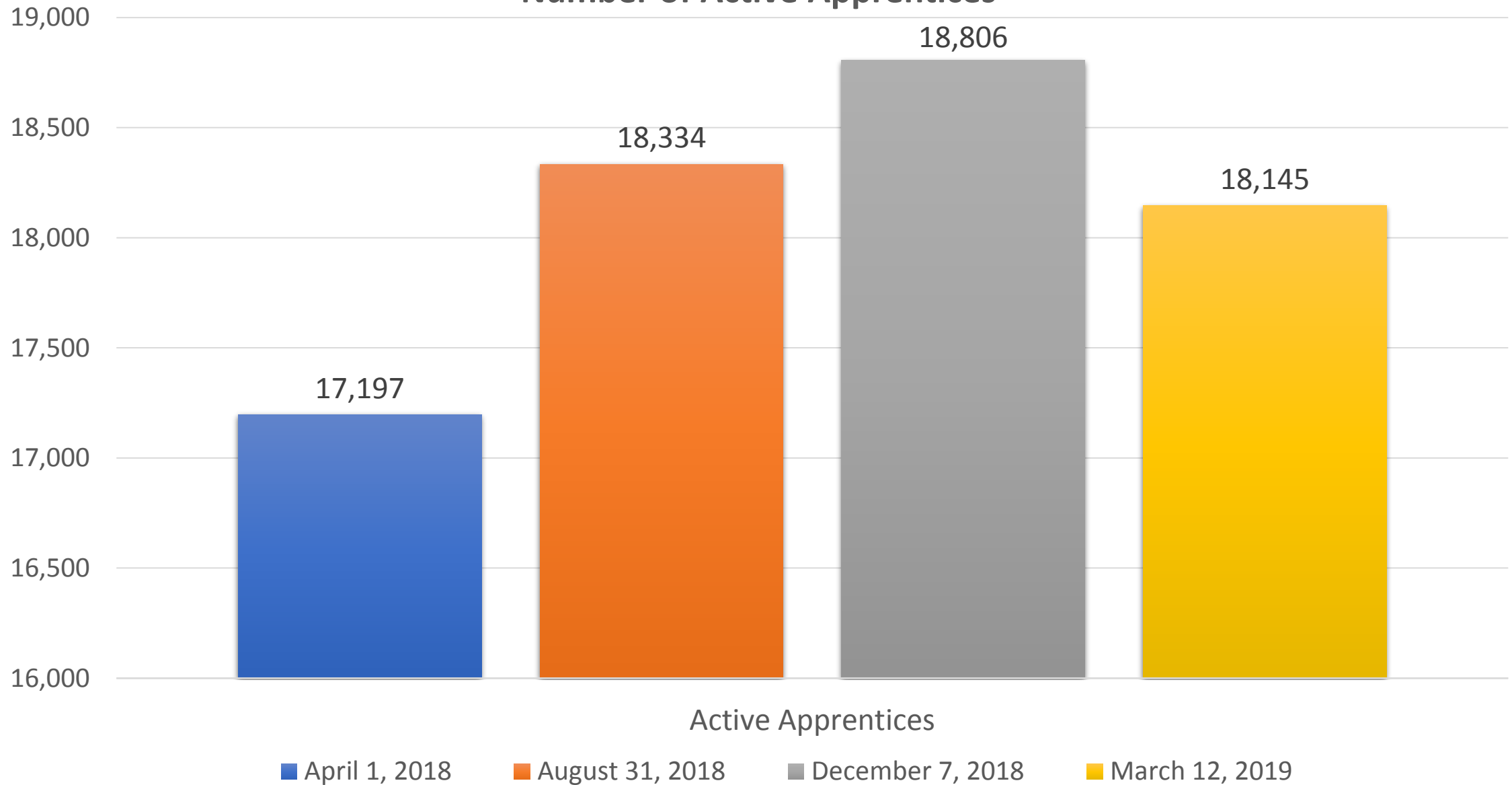
As of March 12, 2019:

- 2,412 Certificates of Completion were issued in 2018

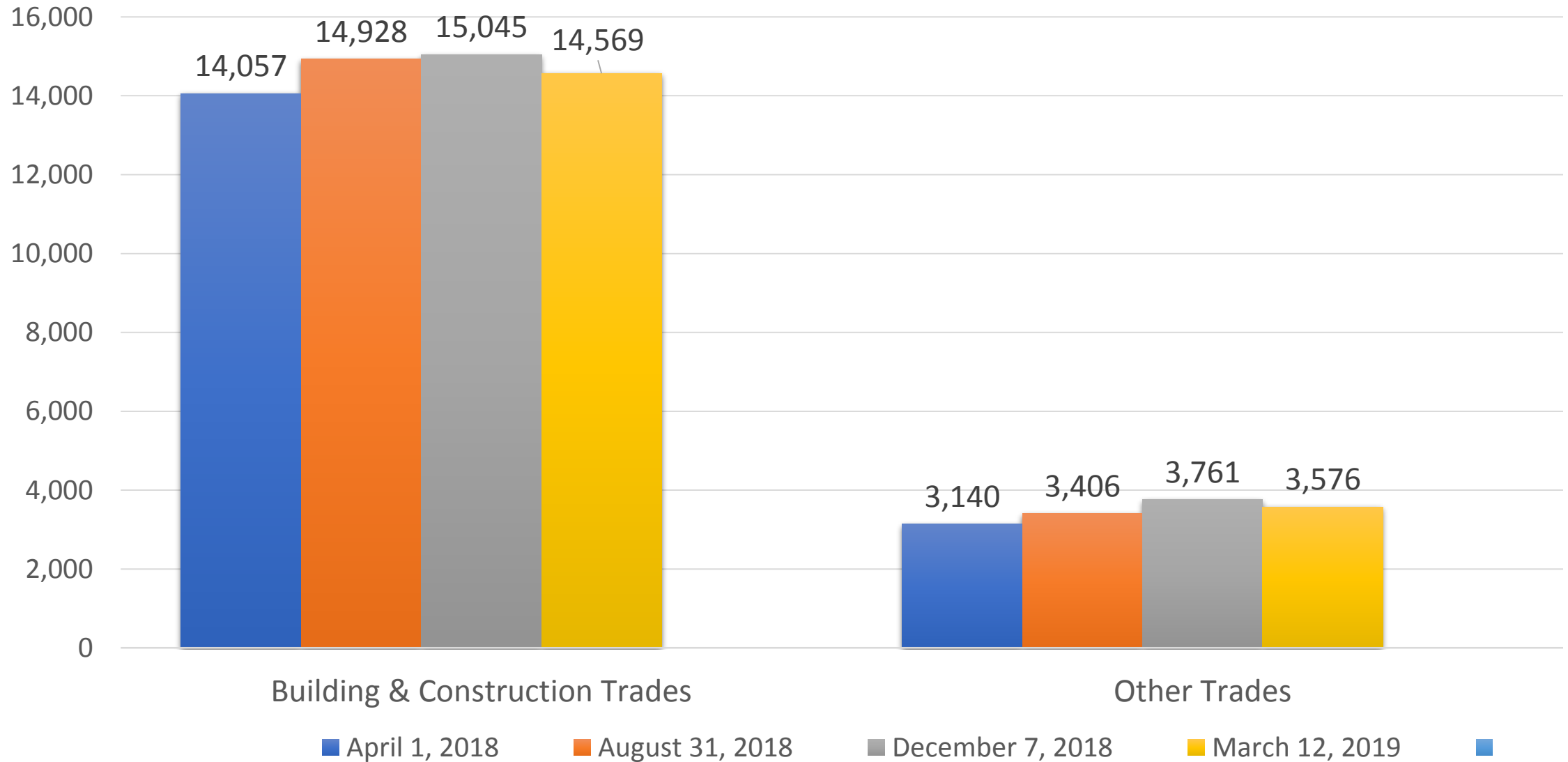
