In November 2024, there were 496,300 private sector jobs and 589,900 nonfarm (private + government) jobs in the region.

Job Gains




The region gained 8,300 nonfarm jobs over the past year, including 7,400 private sector jobs and 900 government jobs.





Population by Race/Ethnicity, 2010 and 2020



Regional Labor Market Developments

Good news

German energy infrastructure company Pfisterer has announced the opening of its first North American manufacturing facility in Gates (Monroe County). This expansion marks Pfisterer's first factory outside of Europe and is expected to create up to 50 new local jobs. Pfisterer's technology specializes in insulating and connecting electrical conductors, supporting power grid interfaces across various environments. The new facility will play a role in assembling dropper cables for offshore wind farms, including the proposed New York Empire Wind project. (rbj.net)

The RochesterWorks Downtown Career Center at Monroe Community College's downtown campus has been awarded \$5.5 million through the Regional Revitalization Partnership to establish a comprehensive one-stop career center. This \$14 million project aims to remove barriers to workforce participation for historically underrepresented populations by co-locating agencies that provide workforce development and supportive services. The center will offer employment assistance, training for career pathways and wrap-around services to job seekers in the Rochester area. (rbj.net)

Eco Waste Solutions, a thermal waste conversion company, has inaugurated a new manufacturing facility in Batavia (Genesee County). The facility is designed to produce Expeditionary Solid Waste Disposal Systems (ESWDS) for the U.S. Army, offering a safe alternative to burn pits in conflict zones. The company plans to hire up to 30 employees at this location to support its thermal treatment technologies production. (wastetodaymagazine.com)

Li-Cycle Holdings Corp. has secured a \$475 million loan from the U.S. Department of Energy to complete its Rochester Hub project (Monroe County), a critical lithium-ion battery recycling facility. The company had paused construction in October 2023 due to financial constraints but is now poised to resume work on the \$960 million project. Once operational, the Rochester Hub will employ about 200 people. (rbj.net)

Other news

A New York State Supreme Court judge has overturned the Department of Environmental Conservation's (DEC) decision to deny Greenidge Generation's air permit renewal for its Bitcoin mining facility on Seneca Lake (Yates County). The ruling allows the facility to continue operations. The facility, which converted a former coal plant to run on natural gas, uses significant power for cryptocurrency mining and employs lake water for cooling its computers. While supporters argue the facility brings innovation and jobs to the region, opponents worry about its environmental impact, including potential disturbances to the lake's ecosystem. The court upheld the DEC's authority to deny permits for operations that may threaten the state's climate goals. (whec.com)
