## WHAT IS A VIRTUAL CAREER FAIR?

By providing an online platform, the New York State Department of Labor has made it possible for businesses and job seekers to connect in a virtual setting in real time, while keeping the familiar feel and positive outcomes of a physical event.

## THE ONLINE PLATFORM

The New York State Department of Labor is excited to introduce this branded digital environment that allows you to find top talent while facilitating a better job hunt experience for potential candidates.

Features include:

- Mobile-friendly design with unlimited user capability
- Customizable exhibitor booths
- Ability to hold a webcast during the live event

## **HOW IT WORKS:**

Sign up! Register for the event using invitation link

**Set up!** Set up your Virtual Booth ahead of the event using logos, images, job descriptions, videos, links, and more!

**Exhibit!** Join the event on the live day by logging into the chat feature

- Engage customers who stop by your booth
- Receive a copy of any resumes of visitors who stopped by your booth

#### **PREVIEW DAY**

The preview day takes place the day before the event and goes until the start of the live event. On the preview day, job seekers can browse the exhibitor booths and various job opportunities ahead of the live event to become familiar with the live site.

### LIVE DAY

The live event is when job seekers can browse the exhibitor booths and various job opportunities, and businesses and job seekers can chat with one another.

- · Review candidate resumes ahead of live day
- Chat one-on-one with candidates to discuss qualifications and job details
- Have multiple recruiters for your company logged in the event to chat!
- Option to video chat candidates
- Review chat conversations and resumes after the event and star select candidates
