NATIONAL APPRENTICESHIP WEEK & NYS APPRENTICESHIP MONTH

- 9th Annual National Apprenticeship Week: November 13-19, 2023.
- Governor Hochul issued a proclamation recognizing November 2023 as NYS Apprenticeship Month.

DIRECT ENTRY FUNDING OPPORTUNITY

- During National Apprenticeship Week, Governor Hochul announced the investment of [\\$2 million](#) to enhance Direct Entry pre-apprenticeship programs across New York State.
- Working on funding opportunity which we hope to post before the end of the year.
- The funding opportunity will be posted to the NYSDOL website.
- Sponsors and interested parties will be notified via email once it posts.

APPRENTICESHIP EXPANSION GRANT

Request for Applications (RFA) Bid Number AEG-4

- Released on March 24, 2023
- Deadline to Apply: August 30, 2024
- \$3M in funding available (100% of this RFA will be financed with federal funds, and no non-federal funds are being used)
- Goal is to expand RA
- 130 apprentices with a focus on underrepresented populations
- Apprentices to enter trades in high-demand occupations
- Funding will cover costs associated with training apprentices through RA

EMPIRE STATE APPRENTICESHIP TAX CREDIT PROGRAM

- Deadline to apply for 2023 – December 31st
- For NYS RA sponsors or signatory employers
- Tax credit for apprentices employed full-time for at least six months
- Enhanced tax credits
 - Disadvantaged youth
 - Apprentices with a mentor
- Focus on demand occupations

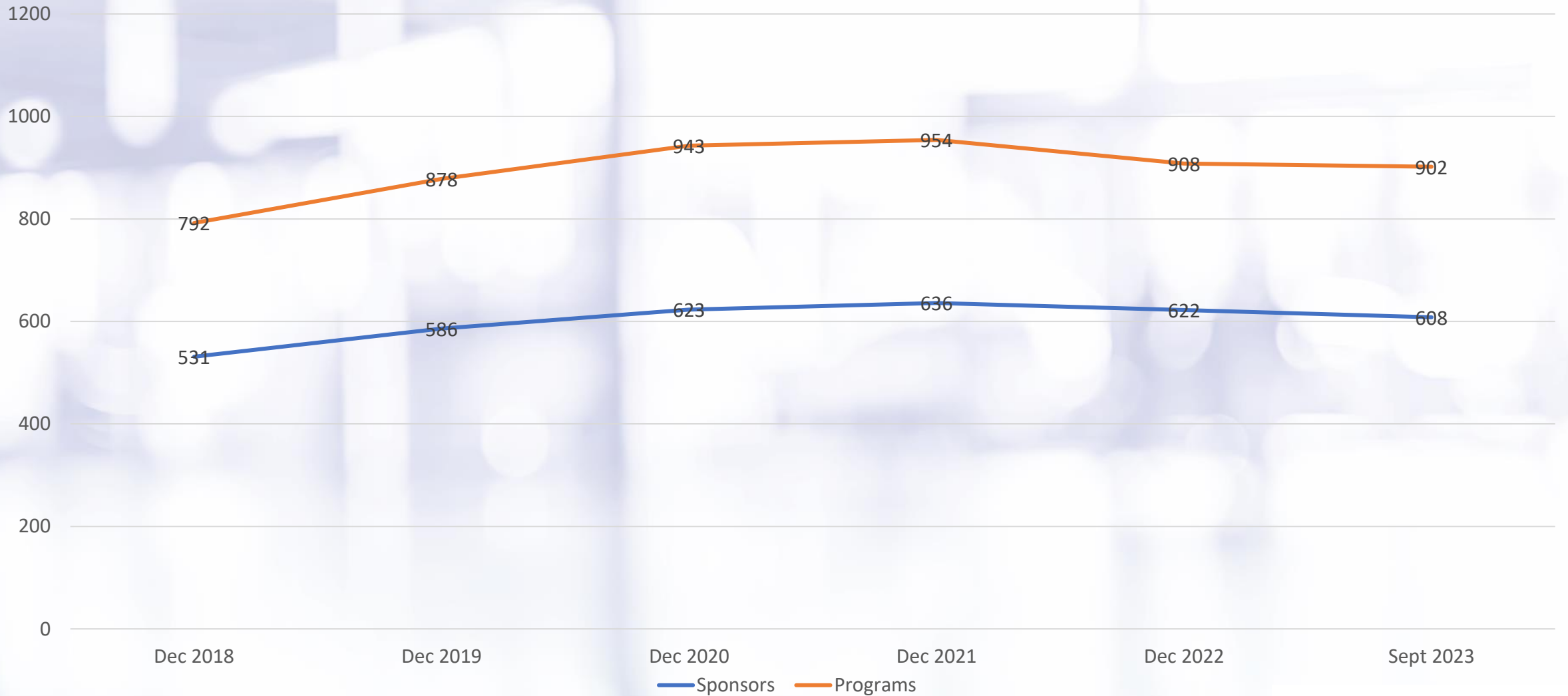

- 1,676 Certificates of Completion issued so far in 2023

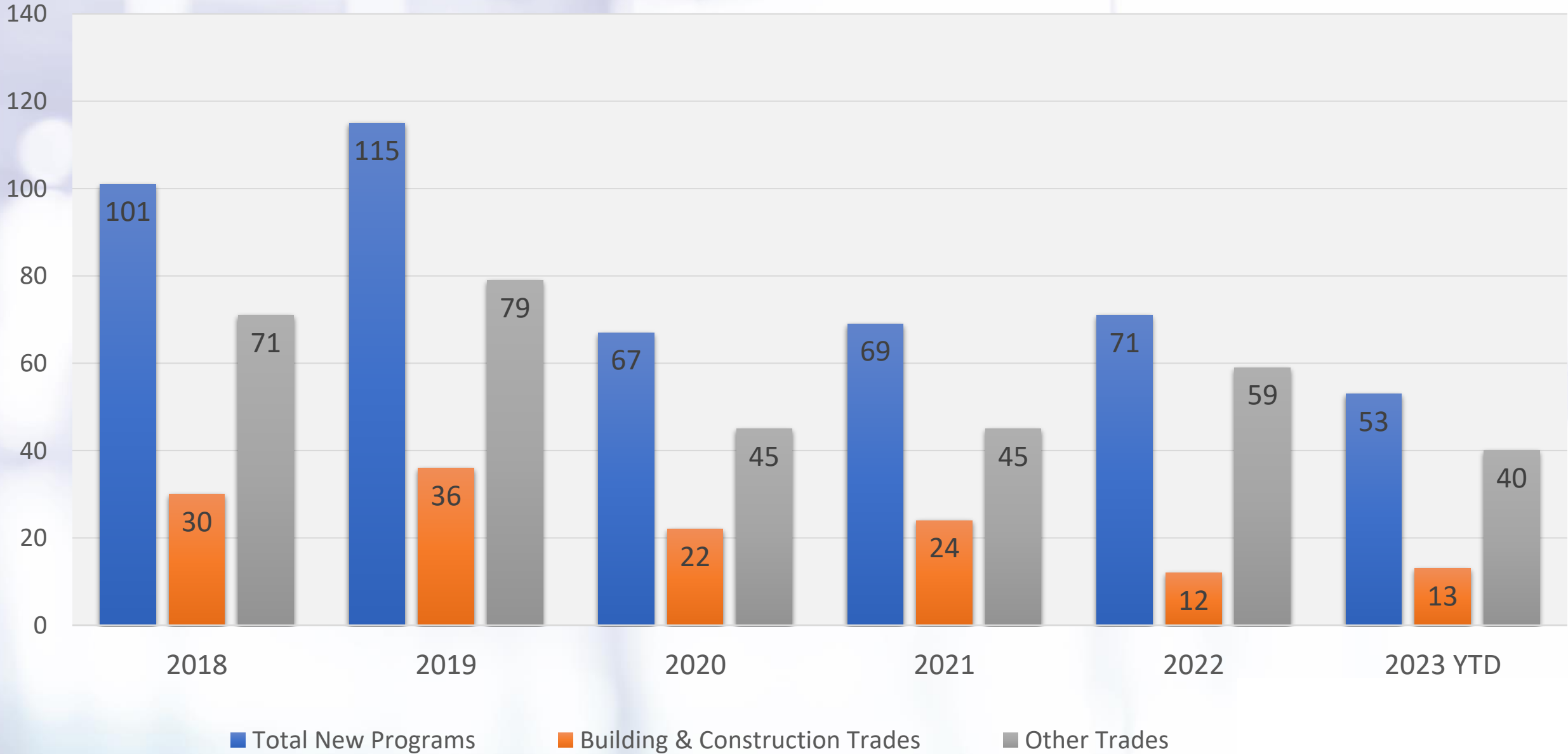
Number of Sponsors/Programs Each Year



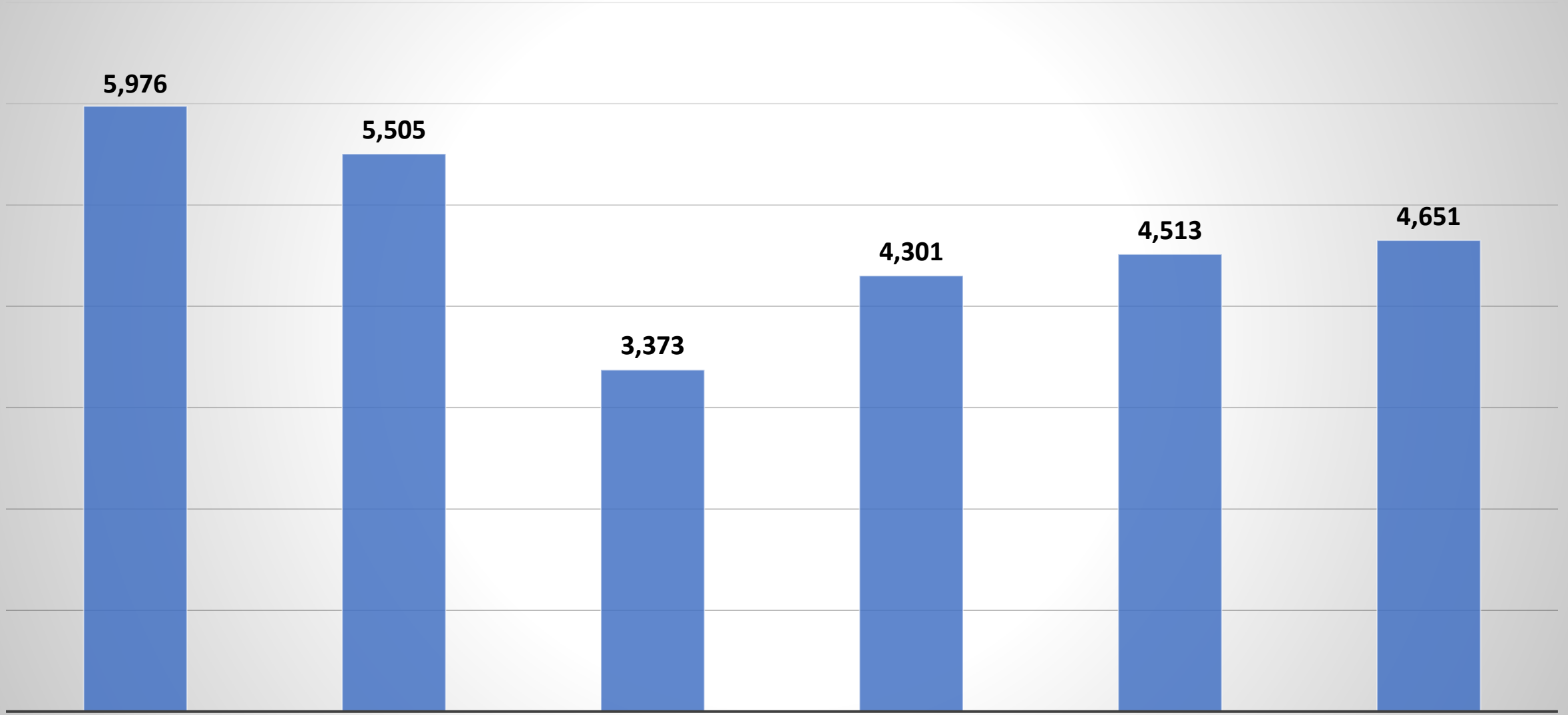
Apprenticeship Programs by Region – as of 9/30/2023

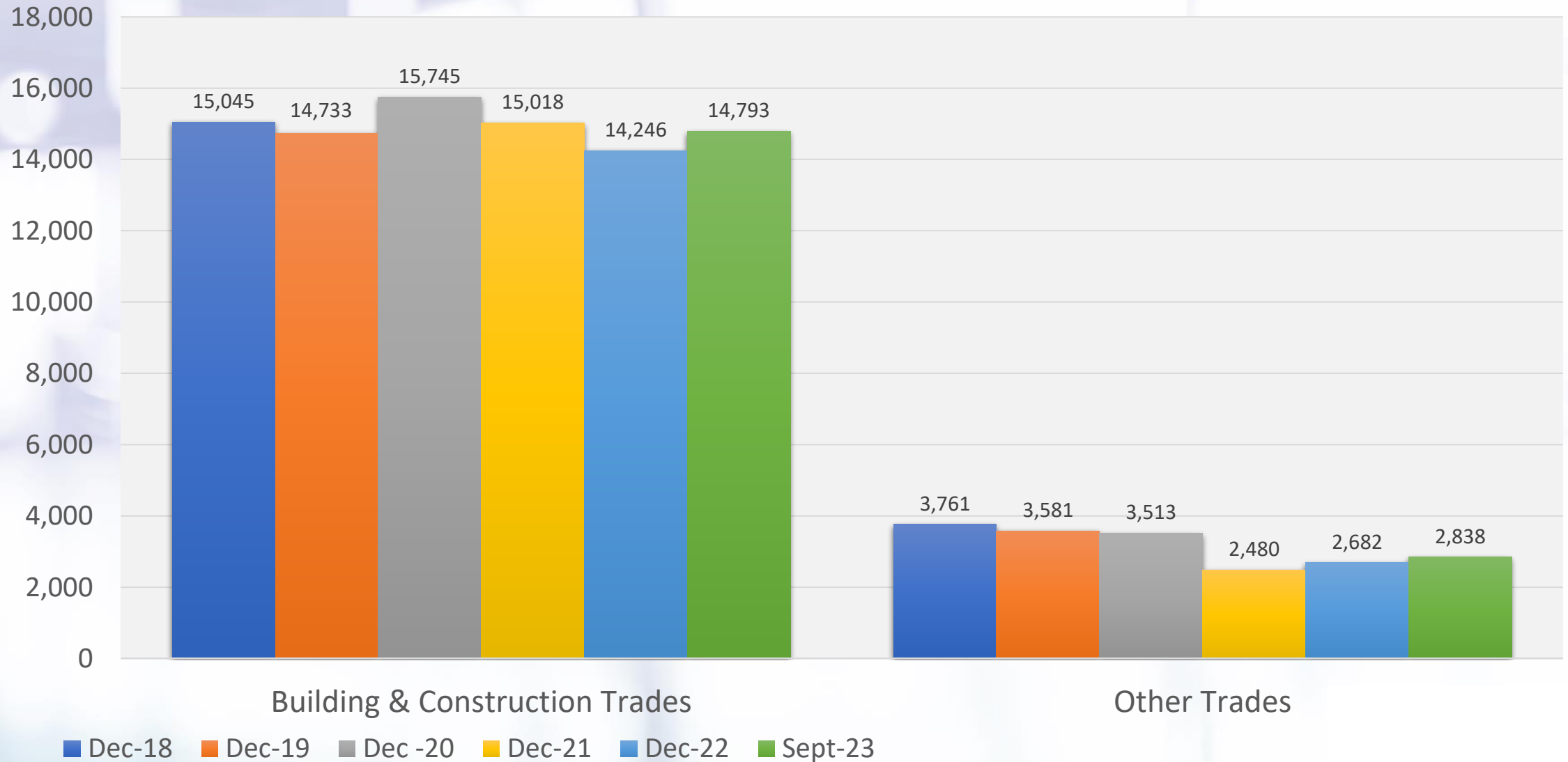


Number of Newly Enrolled Apprentices



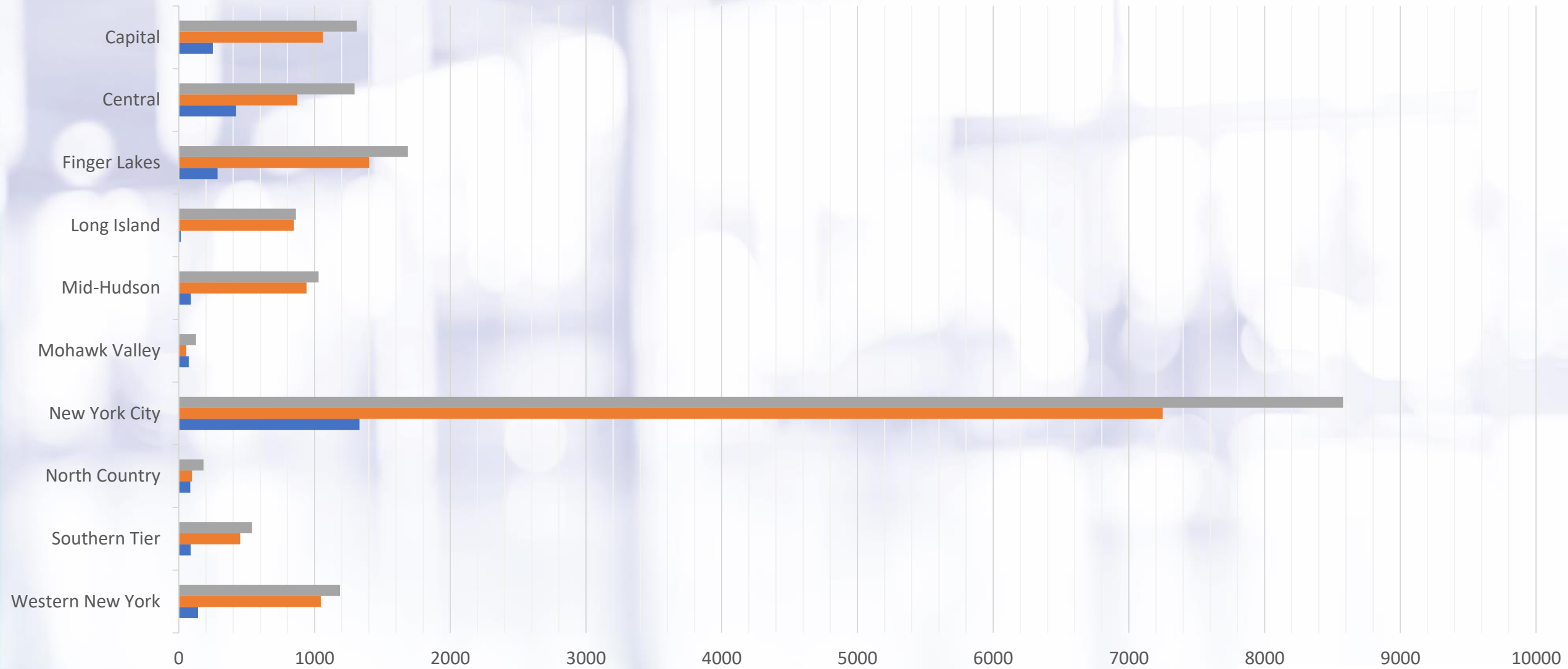

Comparison of the Number of Active Apprentices- Construction & Other Trades

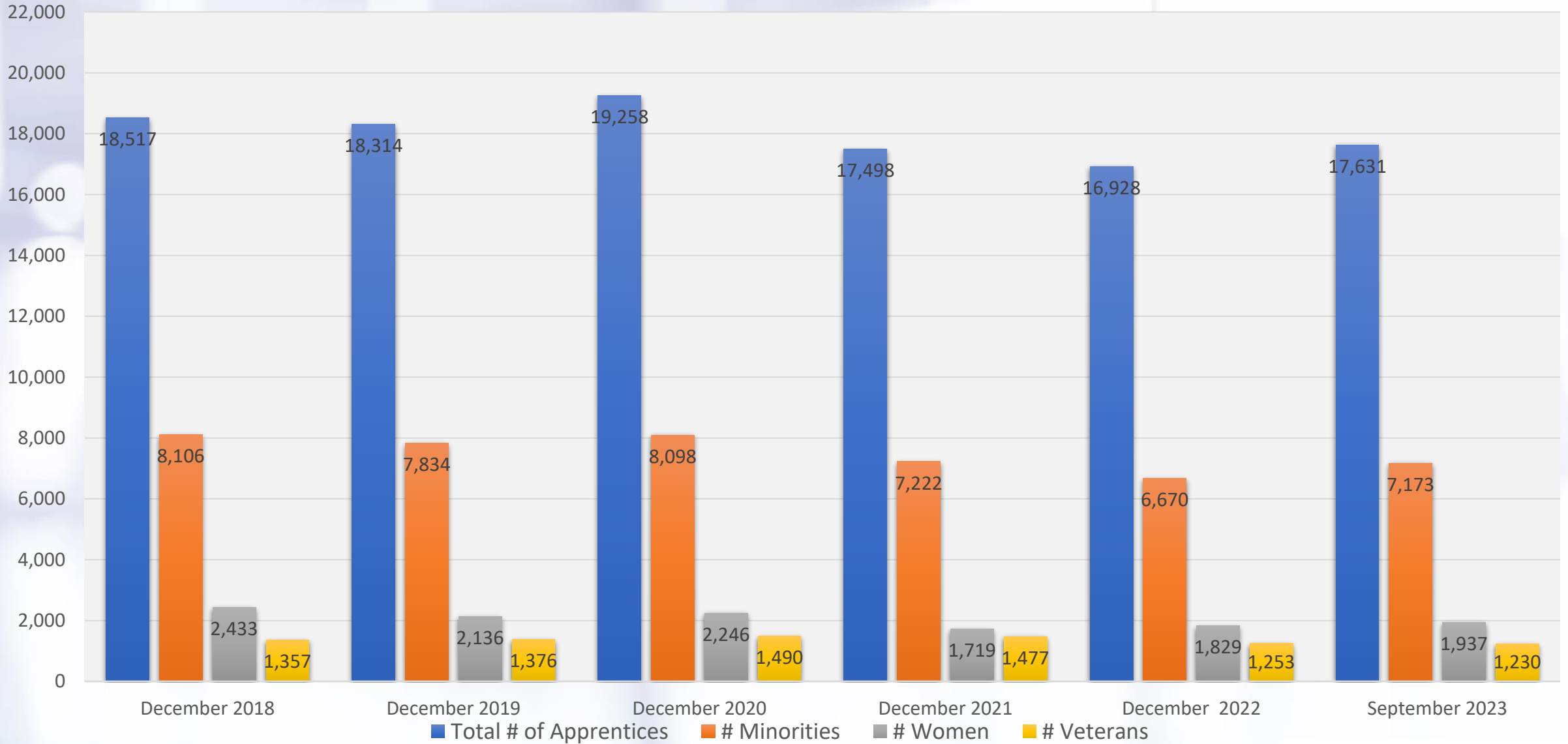


Apprentices by Region – as of 9/30/2023

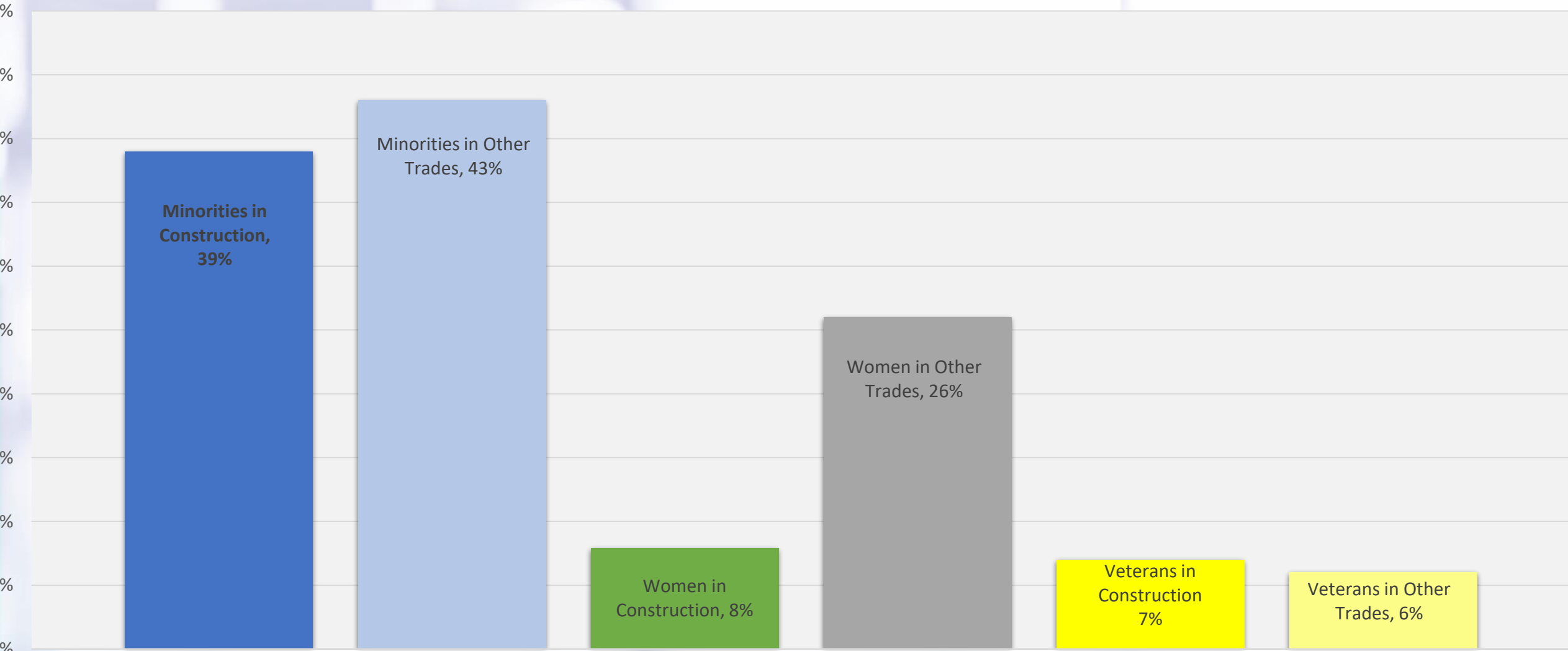

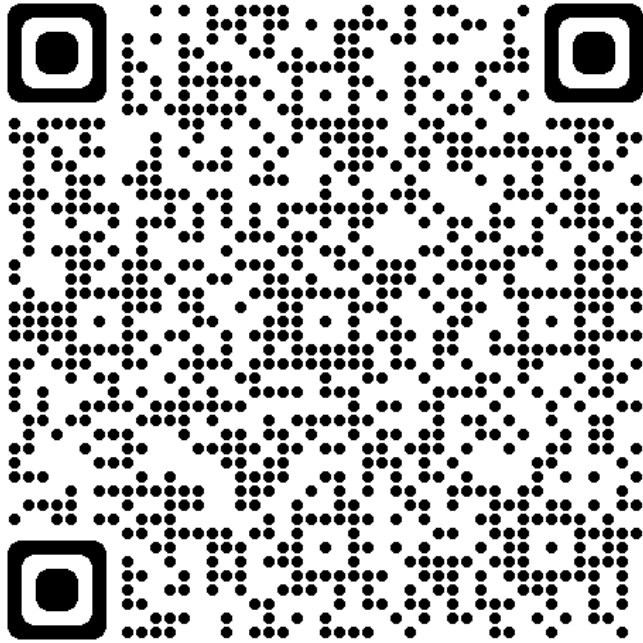

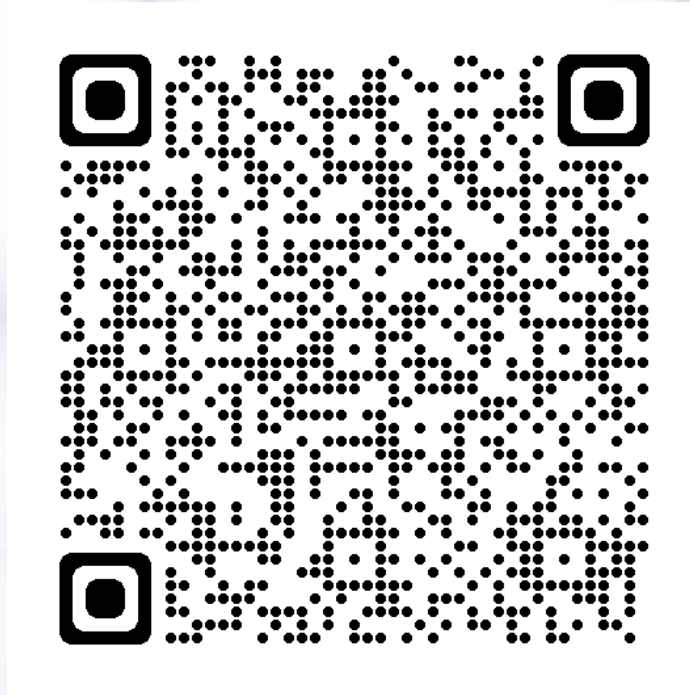
