APPRENTICESHIP

In apprenticeship programs, beginners learn a trade or skill from master level workers. They learn on the job and in the classroom. Available apprenticeship programs in New York State currently include more than 300 occupations in the building trades, manufacturing, and service occupations. We are responsible for approving all apprenticeship programs in New York State.

LABOR DATA

Labor market analysts in our Division of Research and Statistics provide data about wages, important economic trends, and labor availability in their region to employers, developers and others. They also provide occupational and career information to job seekers.

IMMIGRANT POLICIES & AFFAIRS

The Division of Immigrant Policies & Affairs helps workers from other countries use the many programs and services we offer. Our staff can help you:

WAGE PROTECTION

The Division of Labor Standards protects all workers, even if they are paid off the books or are not documented. We work to fight against worker exploitation, sexual harassment and human trafficking.

We enforce the State Labor Law for:

- Minimum wage
- Hours of work
- Child labor
- Payment of wages and wage supplements
- Migrant farm labor
- Conditions in the garment industry

FARM WORKERS

New York State has programs to protect migrant farm workers. Labor Standards Investigators check the working conditions of migrant farm workers and report problems to the proper agency.

CHILD LABOR

New York State strictly enforces child labor laws. The law applies to all workers under age 18. It limits the hours youth may work during the school year. It also says they cannot operate unsafe machinery or work in dangerous jobs.

SAFETY AND HEALTH

The Department of Labor protects employers, workers, and the public from dangers at work and other health hazards. Some of these include:

- Asbestos control
- Occupational safety and health problems in the workplace
- Boiler safety
- Licenses for crane operators, blasters, asbestos workers
- Inspection of ski areas, amusement rides, and places of public assembly

PUBLIC WORK

The Bureau of Public Work administers the prevailing wage law. We:

- Set the rates each year
- Enforce the law

This law says workers must earn the prevailing wage rate if they are employed:

- On public construction projects
- At service jobs in public buildings

UNEMPLOYMENT INSURANCE

If you are unemployed through no fault of your own, you may qualify for weekly benefit payments while you look for work. We will do everything we can to help you return to the workforce.
