KNOW YOUR RIGHTS AS A WORKER

How To Prevent Labor Violations In The Workplace

If you know your rights under the New York State Labor Law, you can protect yourself in the workplace. Here are some basic facts and tips to keep in mind at work.

WAGES

Everyone has a right to earn at least the minimum wage, no matter what the job is, or who the worker may be. If you work more than 40 hours a week, you should get extra pay for the extra time you are working, although there are exceptions for home care workers.

Effective January 1, 2024, farmworkers working more than 56 hours a week must now get extra pay at a rate of 1 1/2 times their regular pay rate for the extra hours of work.

The minimum wage and overtime laws apply to ALL WORKERS, even if you are undocumented or paid:

- Hourly, daily, or weekly
- In cash or by check
- Off the books

WORKERS' COMPENSATION

Regardless of your immigration status, you can receive workers compensation if you are injured on the job. Contact the Advocate for Injured Workers for help at **800-580-6665**.

PROTECT YOURSELF

Write down as much information as you can, in case you need to make a claim. This includes:

- Employer's FULL name (first, last and contact information)
- Address and/or phone number of the place where you worked
- State and plate number of car (if someone picks you up for a job)
- Contact information (names and phone numbers)
- Times you start and stop work (include how much time you had for meals)
- How much the employer agreed to pay you

Write down the company name listed on any permits or licenses, or ask for a business card. Then the employer knows you have their information and will be less likely to break any labor laws.

If you have a camera phone, you can take pictures of the workplace and your coworkers, including the supervisor. This can help you with a claim.

WARNING SIGNS

There are many red flags that can warn you about labor law violations. You may be a victim of wage theft, if you:

- Do not receive a record of hours worked (whether you get paid by check or cash)
- Get charged for equipment needed to work or for damaging property
- Work at least six hours straight and do not have at least a half-hour meal period

If you have a work-related problem with an employer, the Department of Labor can help you make a claim.
