Job Gains




The region gained 16,300 nonfarm jobs over the past year, including 12,400 private sector jobs and 3,900 government jobs.

The region's most significant industry is Government Regional Industry Mix, March 2024





Over-the-Year Change in Jobs, March 2024






Unemployment Rate by Place, March 2024








The State's unemployment rate (4.2%) is less than the region's unemployment rate (4.6%) by -0.4 percentage points.





US Census Bureau Diversity Index Scores, 2010 and 2020







Regional Labor Market Developments

Good news

Buffalo Games, a designer and manufacturer of jigsaw puzzles and board games, plans to add 95 jobs as part of a \$6.5 million expansion after it was awarded low-cost hydropower to support the project, according to the Buffalo News. The company plans to combine its two manufacturing locations, one in Massachusetts and one in Buffalo (Erie County), into the Buffalo location. Currently the game maker employs 102 local employees.

Edelweiss Derry, a dairy farm located in Cattaraugus County, is planning \$32.5 million in upgrades and is seeking a \$15 million tax-exempt bond, according to papers filed with the Cattaraugus County Industrial Development Agency (IDA). The dairy farm plans to replace its existing 50-year-old facility with new structures, including a 120-stall rotary milking parlor, four cattle barns and a manure processing facility that is capable of capturing methane and converting it into renewable natural gas, according to Business First. The dairy, founded in 1962, sells milk, meat and grain products. It has 20 full-time employees and is expected to add 10 more over the next two years.

Deaf Access Services has completed its long-planned merger with Western New York nonprofit, People Inc. The merger expands the People Inc. program portfolio which already includes senior services, affordable housing, health care and services for people with developmental and intellectual disabilities. People Inc. is an Amherst-based nonprofit (Erie County) which has more than 4,000 employees in the area and provides programs and support to more than 12,000 people across Western New York and the Rochester region.

A 33-acre solar farm is in the works for the Town of Evans (Erie County) by Amherst-based (also Erie County) company Solar Liberty. The company is seeking financial incentives of \$3.5 million from the Erie County IDA for the \$20.8 million project that would include the construction of two solar arrays on undeveloped land. According to Business First, the project would generate a combined 8.25 megawatts of electricity that would be enough to power more than 6,000 single family homes.

The Cambria by Choice hotel opened its hotel in Niagara Falls (Niagara County) at the end of March 2024, nearly five years after planning on the hotel began, according to Business First. The project was initially expected to open a year ago at a cost of \$17.8 million, but, after delays, the project will end up costing more than \$20 million. A general manager for the site has been hired and is now beginning the process of hiring 20-30 initial staff with more expected to be hired during the busy season.

North Carolina-based trucking company Old Dominion Freight Line plans to build a new truck terminal on River Road in Tonawanda (Erie County). The company currently operates a facility on Military Road in Tonawanda. The company has purchased 23.5 acres of vacant land for \$1.92 million. Montante Construction will build the 40,000-square-foot terminal at a cost of about \$18 million, according to Business First. There is no word on what plans are for the existing facility once the new one is built.

Developer Douglas Jemal's company has agreed to buy the former Buffalo News complex in Buffalo (Erie County) from Lee Enterprises after Uniland Development backed out of a reported \$9.05 million deal in February 2023. The purchase enhances Douglas Development's downtown real estate holdings near Canalside as Jemal already owns the former HSBC Atrium building which is located between The News' parking lot and KeyBank Center and Seneca One tower. It is not yet known what the development plans are for the former Buffalo News property.

One of the region's largest health care providers, Evergreen Health, is moving forward with its plans for a new three-story medical office building in the city of Buffalo's (Erie County) Kensington-Bailey neighborhood as it works to expand its existing services for the East Side community. Nearly a year after purchasing four mostly vacant properties, the new 36,000-square-foot building would house Evergreen's Community Access Services affiliate. The \$14 million project would replace an existing medical facility that it has occupied since 2018, according to the Buffalo News.

Indus hotels and its parent company, Indus Hospitality Group, are renovating a 50-room Microtel Inn & Suites by Wyndham in the Town of Allegany (Cattaraugus County). The \$1.75 million project was awarded \$924,400 in subsidies from the Cattaraugus County IDA. According to the Buffalo News, 13 jobs will be retained and four more will be added.

Buffalo native Pater Marlette Jr. announced the formation of Buffalo Pro Soccer and his plan to bring a United Soccer League Championship Club to the Buffalo area by 2026, according to Business First. Leaders are now looking for a place to build a stadium that would become the permanent home for Buffalo Pro Soccer. The league is in talks with landowners scouting sites that would allow the stadium to house about 10,000 people.

Bad news

Fisher-Price in East Aurora (Erie County) has laid off between 75 to 100 workers at its headquarters, as the company moves three of its brands to the Mattel headquarters in El Segundo, California. Some workers in a variety of positions in the Barney, Thomas & Friends and Imaginext brands were laid off; their last day was March 29, 2024. Other workers will stay on into June 2024 to see the brands through the transition to the California site, according to Business First.

On March 8, 2024, thirteen teachers, two teacher aides, a computer aide and a maintenance mechanic at Hamburg Central School were told they would be laid off and their positions would be eliminated due to budget constraints at the end of this school year, according to the Buffalo News. Parents, students and teachers attended a school board meeting on March 12th to object to the teacher layoffs. The superintendent stated the district overestimated revenues and underestimated expenses in the 2021-22 and 2022-23 budgets.
