- 5. First Aid (6.5 hours minimum every 3 years)
- 6. Sexual Harassment Prevention Training must comply with section 201-g of the Labor Law.
- 7. Drugs and Alcohol Awareness
- 8. Diversity in the Workplace
- 9. Scaffolding Safety

#### **Trade Theory and Science**

- 1. Working materials and their use (tile, marble, terrazzo)
- 2. Handling and distribution of various materials and storage care
- 3. Preparation of various surfaces, both floor and wall
- Mortar mixes, terrazzo mixes, chip selection, thin set coat materials
- 5. Portland cement and various applications
- 6. Mortar mixing, hand, or power-related methods
- 7. Tile, marble and terrazzo grouts of various composition and their application
- 8. Safe care and use of various tools and power-related equipment

- Types of synthetic and/or chemical mortars and bonding materials
- 10. Types of synthetic and/or chemical grouts, and their use and application
- 11. Cleaning acid, steam, and power equipment cleaning
- 12. Application of various types of protective coverings and/or sealants for use over all tile, marble, and terrazzo surfaces.
- 13. New Products, materials, work techniques and the use of job-related power equipment and tools used in the tile/marble/terrazzo industry
- 14. Materials Safety Data Sheet

A Minimum of 144 Hours of Related Instruction are Required for Each Apprentice for Each Year.

#### ATTACHMENT TO APPENDIX B

#### **Asbestos Awareness**

This course must be delivered by one of the following:

- 1. A provider currently approved by the New York State Department of Health to deliver asbestos safety training.
- 2. A person holding a current Asbestos Handler certificate from the New York State Department of Labor in the title of: Inspector, Supervisor, Project Monitor, Management Planner, or Project Designer.
- 3. Anyone otherwise approved by the New York State Education Department.

Minimum course contents must include the following:

- 1. Definition of asbestos
- 2. Types and physical characteristics
- 3. Uses and applications
- Health effects:
  - Asbestos-related diseases
  - b. Risks to families
  - c. Cigarette smoking
  - d. Lack of safe exposure level
- 5. Employer-specific procedures to follow in case of potential exposure, including making a supervisor or building owner immediately aware of any suspected incidental asbestos disturbance so that proper containment and abatement procedures can be initiated promptly.

Notwithstanding the above course requirement, employers are advised that they must also be in compliance with New York State Department of Labor Industrial Code Rule 56 at all times.

Employers are further advised, and must advise all apprentices, that completion of the above course requirement does not authorize any person to remove, encapsulate, enclose, repair, disturb, or abate in any manner, any friable or nonfriable asbestos, asbestos containing material, presumed asbestos containing material, or suspect miscellaneous asbestos containing material.
